Products Covered; Non-Transferability. This Limited Warranty Coverage only applies to Architectural Class I and II Products, and only extends to the original Customer. This Limited Warranty Coverage cannot be transferred or assigned.

Architectural Class I and II Limited Warranty Coverage. Lorin hereby extends the following Architectural Class I and II Limited Warranty Coverage to Customer on the Products:

Anodized Bonded Surface Limited Warranty: Lorin warrants that the surface of the Products covered by this Class I and II Surface Limited Warranty will not chip, flake, peel, blister, crack, or split, for a period of seventy (70) years from the date the Product is shipped.

Color Fade Limited Warranty: Lorin extends the following Color Fade Limited Warranty Coverage on finishes and inorganic colors designated by Lorin for exterior use, which meet the "Architectural Class" criteria as defined from time to time by the AAMA.

- Products with Colorin® Medium Antique Copper, Copper Penny, and Gold color are warranted against color fade for twenty (20) years from the date the Product is shipped.
- Products with other finishes and inorganic colors designated by Lorin for exterior use, which meet the "Architectural Class" criteria as defined from time to time by the AAMA are warranted against color fade for fifty (50) years from the date the Product is shipped.

Coverage under this Color Fade limited warranty applies on to color face more than five (5) Hunter ΔE units, determined by ASTM method D-2244 (as amended from time to time).

Additional Maintenance Requirements and Exclusions: This Architectural Class I and II Surface and Color Fade Limited Warranty Coverage does not apply under the following conditions and circumstances (in addition to the exclusions from Limited Warranty Coverage set forth in Lorin's Base Limited Warranty):

- Products which are not adequately maintained to avoid and minimize long-term exposure to contaminants such as dust and dirt. The Customer should conduct regular maintenance of the Product using a non-abrasive, mild soap and water or PH neutral cleaners, with additional rinsing every two (2) years.
- Forming which incorporates severe reverse bending or which subjects the Product surface to alternate compression and tension.
- Any failure to provide free drainage of water, including internal condensation, from overlaps and all other surfaces of the Product.
- Any failure to remove debris from overlaps and all other surfaces of the Product.
- Damage caused to the metallic coating by improper roll forming, scouring, or cleaning procedures.
- Deterioration of the Product caused by contact with green or wet lumber, or wet storage stains caused by water damage or condensation.
- The presence of damp insulation or other corrosive materials in contact with, or close proximity to, the Product.
- Deterioration in the Product caused directly or indirectly by contact with fasteners. The selection of suitable long-lasting fasteners to be used with the Product is Customer's sole responsibility.

Remedies: The **sole and exclusive** remedy under this Architectural Class I and II Limited Warranty coverage is the repair of any warranted defects, or the furnishing of sufficient anodized aluminum product (FOB Customer's plant) to enable Customer to fabricate replacement products (in place of the defective Lorin Product).

Other Terms Applicable. All other requirements, exclusions, terms and conditions set forth in Lorin's Base Limited Warranty are applicable to this Architectural Class I and II Limited Warranty.
